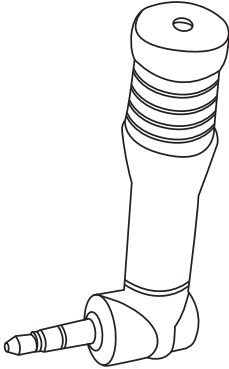

Mini PC Microphone MM760M



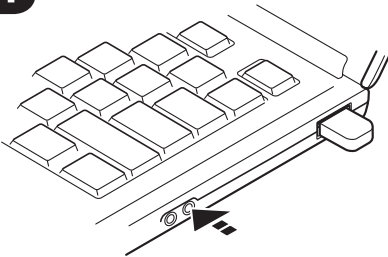
System Requirements:

Plug the microphone's 3.5mm connector into the microphone input on the computer.

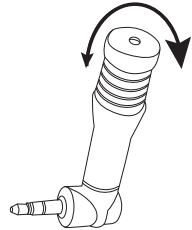

Set appropriate microphone volume levels by experimenting with microphone positioning. To adjust positioning, simply rotate the microphone clockwise or counterclockwise in the microphone input.
